- 2. The last paragraph of Section 5, Article IX, is hereby amended to read as follows:

THIS IS NOT

Notwithstanding anything herein to the contrary, so long as the Declarant, or its assigns shall own any Lot no amendment shall diminish, discontinue or in any way adversely affect the rights of the Declarant under this Declaration, nor shall any amendment pursuant to (b) or (c) above be valid unless approved by the Declarant, as evidenced by its written joinder. Any amendment to this Declaration which would affect any SWMS located within the Properties must have the prior approval of SWFWMD; such approval need not be recorded.

- 3. Section 9 of Article IX is hereby deleted in its entirety.
- 4. The Articles of Incorporation of the Association, which are Exhibit "B" to the Declaration, are hereby amended as shown on Schedule "1" attached hereto and made a part hereof.
- 5. The Bylaws of the Association, which are Exhibit "C" to the Declaration, are hereby amended as shown on Schedule "2" attached hereto and made a part hereof.
- 6. The Declaration, as amended, is hereby incorporated by reference as though fully set forth herein and, except as specifically amended hereinabove, is hereby ratified and confirmed in its entirety.
- 7. This Amendment shall be effective immediately upon its recording in the Public Records of Hillsborough County, Florida.


